The Alabama Sheriffs Association will hold the 2022 Winter Technology Conference on February 27 - March 2, 2022, at the Auburn Marriott Opelika Resort & Spa at Grand National in Opelika, Alabama.



Sheriffs, Deputies, and Guests

Once registered and paid for the conference, Sheriffs, deputies, and guests will make hotel reservations through the association office by phone (334.264.7827) or email (susan.harris@alabamasheriffs.com). No credit card is required to make the hotel reservation; you will present your payment method to the hotel upon checking in. All hotel reservations are for standard rooms (run of the house); upgrades may be requested upon checking into the hotel.

The deadline for making hotel reservations is Thursday, January 27, 2022. After this date, reservations depend on the availability of rooms at the hotel, but the room rate may not be available.

Room Rate \$142.00 plus 13% for state and local taxes

Vendors

For vendors, once registered and paid, the hotel's Booking ID will be emailed to the email address listed on the registration form to make your reservations directly with the hotel.

Premium vendor tables are located in the pre-function area and include two representatives from the same company; 20 of these are available. Standard vendor tables are located in the ballroom and include one representative. Additional representatives may be registered at an additional fee as indicated on the Vendor Registration form.

Vendors will set up on Sunday, February 27, between 10 am and 2 pm. The vendor hall will be open:

Sunday from 2 pm - 7 pm

Monday from 8 am - 5 pm

Tuesday from 8 am - 12 noon

The vendor hall must be cleared of all belongings by 2 pm on Tuesday
